Blue Card (EU) Visa for academics

(Section 18g Residence Act)

Basic information

- Please see basic information on applying for a visa on our website.
 Applications can only be submitted via the <u>Consular Services Portal</u>.
- The German mission is only competent should you have your permanent residence in Tanzania
- Documents not in the German language must be submitted with a certified German translation. A translation of the personal data page of the passport is, however, not required.
- Certificates, diplomas, etc. must be presented in the original with apostille/legalization at the time of your interview.
- The visa must, where applicable, be approved by the Federal Employment Agency and the competent foreigners authority. The visa can only be issued when these approvals have been received.
- Processing time is circa six weeks but can take longer in individual cases.
- Flight reservations are not required to apply for a visa please only book when you have received your visa and refrain from booking before.
- The mission abroad reserves the right to request further documents at all times.
- Missing documentation delays the procedure and can result in your application being rejected.
- Please do not contact the mission abroad to check the status of your application during the normal processing period. Such inquiries are extremely time-consuming for the visa section and can thus not be answered.

General information

To apply for the Blue Card (EU) for academics in Germany you will need

- an academic degree comparable with an academic degree in Germany,
- an employment of a duration of at least six months in Germany corresponding to your qualifications and
- a minimum annual gross salary of EUR 48.300,-/4.025,-€ monthly. For employment in the fields of STEM and other bottleneck professions, a gross annual salary of at least EUR 43.759,80 (in 2025)/3.646,65€ monthly is sufficient. If you obtained your last degree or equivalent qualification less than three years ago, you can also obtain an EU Blue Card if your job (all academic professions) includes a gross annual salary of at least EUR 43.759,80- (in 2025). In these cases, your employment must be approved by the Federal Employment Agency (BA). If you wish to work in a regulated profession, for instance, in a health profession, a professional licence is mandatory.
