Visa for recognition of foreign qualifications

(Section 16d Residence Act)

Basic information

- Please check the basic information on the website first
- The German mission is only competent should you have your permanent residence in Tanzania
- Documents not in the German language must be submitted with a certified German translation. A
 translation of the personal data page of the passport is, however, not required.
- Certificates, diplomas, etc. must be presented in the original with apostille/legalisation.
- The visa must be approved by the Federal Employment Agency in Germany or the competent foreigners authority. The visa can only be issued when this approval has been received.
- Processing time is as a rule ca. three months but can take longer in individual cases.
- Flight reservations are not required to apply for a visa please only book when you have received your visa.
- The mission abroad reserves the right to request further documents.
- Missing documentation delays the procedure and can result in your application being rejected.
- Please do not contact the mission abroad to check the status of your application during the normal processing period. Such inquiries are extremely time-consuming for the visa section and can thus not be answered.
- All documents need to be presented in the original as well as with one set of copies. Tanzanian
 documents need to be legalized. Documents neither in English or German need to be translated.

General information

If your vocational training has not been fully recognized by the competent German agency, you can apply for a visa to complete the necessary training in Germany and at the same time start to work. After completion and full recognition of your training, you can apply for permanent residence in Germany.

Please note that some university degrees from foreign universities are classified as vocational training in Germany.

	Proof of sufficient means of subsistence
	To stay in Germany the applicant must have at their disposal at least $1.091 \in$ net per month for theoretical/scholar forms of recognition or $941,-6$ net/ $1.133,-6$ gross per month for practical forms
	of recognition when trained by a company. Proof of these means is to be provided in advance
	when the application is submitted. If a salary will not be received directly after entering Germany
	or if the net salary is less than 941,-€ net/1.133,-€ gross per month, provision of the monthly
	shortfall of funds must be proven separately, for example, in the form of a blocked account or
	formal letter of obligation ('Verpflichtungserklärung').
	Proof of health insurance
	Persons with statutory health insurance cover are adequately insured from the first day of work. Please provide proof of your statutory insurance cover.
	If you arrive before the statutory health insurance cover begins, you must take out appropriate



	supplementary insurance.		
	If a long or permanent stay is planned, some travel health insurance policies may exclude insurance cover in their terms and conditions.
